Seminar Overview/Statement of Purpose:

Healthcare practitioners are currently faced with the challenges of both treating and preventing the ever- increasing incidence of chronic diseases in the US population. In addition, the need to adapt best practice models in the context of emerging healthcare reforms impacting patient care delivery and access to care is an important issue for all healthcare practitioners to address.

The health care community in Costa Rica has been able to offer affordable health care and rapid advancements without the burgeoning costs we face in North America. Along with high rankings for overall medical care, affordability and availability for all Costa Ricans; Costa Rica now has a category of tourism referred to as "Medical Tourism". Many of the country's highly trained physicians and some dentists work in the mornings for the CCSS (Caja Costarricense de Seguro Social, the government sponsored network) and operate their own offices and clinics in the afternoons and evenings. This program will review how Costa Rica has used a system for 60 years that is able to meet the needs of all of their citizens. In addition foreigners living in Costa Rica that are legal residents can join the CCSS and get free treatment (everything from checkups to prescription drugs to major surgeries) by paying a small monthly fee–based on income. Tourists and visitors can use Caja facilities only in emergencies. Confronting the challenges of providing quality patient care in the face of limited budgets and resources that impact healthcare delivery and access, is fast becoming a global issue for healthcare practitioners.

We explore these challenges with in-country professionals and provide opportunities for practitioners to enhance healthcare delivery models and best practices to prevent and control disease in cross-cultural environments.
